Head Lice Inspections

Throughout the year, the school will be arranging head lice inspections of students. The management of head lice infestation works best when all children are involved in our screening program. The school is aware that this can be a sensitive issue and is committed to maintaining student confidentiality and avoiding stigmatisation.

Before any inspections are conducted staff will explain to all students what is being done and why, and it will be emphasised to students that the presence of head lice in their hair does not mean that their hair is less clean or well kept than anyone else's. It will also be pointed out that head lice can be itchy and annoying and if you know you have got them, you can do something about it.

The person conducting the inspections will physically search through each student's hair to see if any lice or eggs are present. **In cases where head lice are found, the person inspecting the student will inform the student's class teacher and the principal. The school will send a written notice home with the child and provide parents with comprehensive advice about the use of safe treatment practices which do not place children's health at risk.**

Please note that the law requires that where a child has head lice, that child should not return to school until appropriate treatment has commenced.

Student Agreement for use of Internet and Email

Port Fairy Consolidated School is pleased to offer students access to the Internet and electronic mail (email) facilities only when supervised. We strongly believe in the educational value of these electronic services and recognise their potential to support student learning. Port Fairy Consolidated will make every effort to protect students from any misuse or abuses using telecommunications. The responsibility for setting and conveying standards and dealing with inappropriate material is a joint responsibility with students, families and the school. We believe that access is a privilege – not a right as access involves responsibility. Please discuss the following guidelines for using the internet and email with your child.

Guidelines :

Be Polite – Netiquette

Always send messages that are polite. When you are on-line you are representing Port Fairy Consolidated School.

Be Responsible –

Don't deliberately access undesirable sites. Discuss any concerns you have about any information accessed with a teacher. Internet & e-mail use is only available when a teacher is present in the room.

Privacy –

Don't include any personal information like your full name, home address or phone numbers. Let your teachers know if any person is asking for personal information.

Information –

All the information accessed through the internet may not be accurate. Every effort will be made to ensure children develop skills to assist them to validate information.
